- All Lunch Applications should be completed in full (all pink-highlighted sections) and returned to one of the above locations to ensure that it will get processed properly and in a timely fashion.
- **Please be informed that your “Medical Card Number” DOES NOT qualify your child(ren) to receive Free or Reduced lunch. The “Medical Card Number” provided to you and your family is a “Personal I.D. Number” for your child(ren) and should not be given out to others for security reasons.**
- All Lunch Applications should be submitted prior to the start of school, Tuesday, August 13, 2019 to ensure that your child(ren) will receive breakfast/lunch if eligible. Failure to complete this form will result in delay of eligibility breakfast/lunch status, as well as delay of any fee waiver(s) that you may be eligible to receive.

### **IMPORTANT NOTE: (FEE WAIVER)**

Any family household submitting a Lunch Application after November 1, 2019 will forfeit the opportunity to have their registration fee waived.

**EXCEPTION:** Student(s) is a “New and Active” student attending Morton High School and/or student(s) transferred to Morton High School from another School District.
